Gene's recommendation is to sign and accept the bid, and approve 10% additional for contingencies (portion of old deck must be removed for tie-in, may encounter some problems not otherwise visible.) Request to approve \$20,160. A prior Board decision authorized \$15,000; this proposal authorizes an additional \$5,160. Before signing the bid, Gene will make 3 revisions for agreement with Howland: 1)keep an opening from new ramp to existing bathroom, with a single step up (instead of a railing), 2) adjustment to siting of new ramp so it ends far away enough from north wall of 113 School to not obstruct opening of bathroom windows, 3) modify plan to take out proposed guardrail between old deck and new deck. New deck will have a 1.5" bumper to prevent wheelchairs from falling off. As soon as it's approved, Howland will calendar the project.
